## WHAT DOES TEXAS BANK AND TRUST DO WITH YOUR PERSONAL INFORMATION?

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. How does Texas Bank and Trust protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.	
	We restrict access to personal & account information to only those employees who need to know to provide products and services to you.	
How does Texas Bank and Trust	We collect your personal information, for example, when you

Definitions		
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.	
	Texas Bank and Trust does not share with our affiliates.	
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.	
	<ul> <li>Texas Bank and Trust does not share with nonaffiliates so they can market to you. We only share to market our products and services to you.</li> </ul>	
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.	
	- Texas Bank and Trust does not jointly market.
